AGREEMENT: In consideration for and as a condition of being allowed to participate/and or compete in all or any part of the Responder Relief Rodeo, the above named participant, volunteer, or, in the event the participant is a minor, the consenting parent or legal guardian, ("Signor") acknowledges and agrees to the following:

ACKNOWLEDGEMENT OF RISK: The Signor acknowledges those dangerous activities and that a person's participation in any capacity will expose the participant to a SUBSTANTIAL AND SERIOUS RISK OF PROPERTY DAMAGE, PERSONAL INJURY AND/OR DEATH.

The Signor expressly acknowledges that participation in the Responder Relief Rodeo may expose them to such hazards. Contestants, participants and parents acknowledge that rodeo/equine events and activities are inherently dangerous activities.

All participants agree to assume such hazards and risks.

WARNING — Under Colorado Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Article 13-21-119, Colorado Revised Statutes.

RELEASE OF SPONSORS: THIS IS A RELEASE OF LIABILITY, ALL PARTICIPANTS AND PARENTS ARE AGREEING TO RELEASE RESPONDER RELIEF RODEO, RESPONDER RELIEF FOUNDATION, FACILITY HOUSING EVENT AND OTHER PARTIES FROM LIABILITY.

PLEASE READ THIS PROVISION CAREFULLY. The Signor, being fully aware that participation in the Responder Relief Foundation and Rodeo events will expose the participant to a substantial and serious risk of property damage and/or personal injury and/or death, hereby agrees to release Responder Relief Foundation and Rodeo, Facility and/or any and all sponsors (including their officers, directors, employees, volunteers, agents or affiliates) from liability for any and all property damage, personal injuries, or other claims arising from participant's participation in the Responder Relief Foundation and Rodeo, including those that are known, foreseen and unforeseen, future or contingent, and includes claims, demands and liabilities arising negligence of the parties so released. Furthermore, to the fullest extent permitted by applicable law, this discharge waiver and release also includes claims, demands and liabilities arising out of gross, willful or wanton negligence of the parties so released. This discharge also includes claims, demands and liabilities for indemnities and contributions arising from property damage, personal injury and/or death to a third party.

In the event that any provision of this discharge, waiver and release is determined to be invalid for any reason, such invalidity shall not affect the validity of any of the other provisions, which other provisions shall remain in full force and effect as if this discharge, waiver and release had been executed with the invalid provision eliminated. The undertakings and covenants of the foregoing provisions shall be binding upon each contestant, participant and parents, his or her heirs, legal representatives, successors, and assigns.

INDEMNIFICATION: Each contestant, all participants and parents agree to indemnify, defend, save and hold harmless including, without limitation, the Responder Relief Foundation and Rodeo, the Facility, directors members, other contestants, stock contractors, rodeo committee, rodeo producer and contract personnel and all event sponsors from any and all claims, demands and liabilities for any and all property damage, personal injury and/or death asserted by a third party defined as any other party other than the Responder Relief Foundation and Rodeo and arising from such participation in Responder Relief Rodeo.

COVENANT NOT TO SUE: The Signor covenants that the Signor shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against Responder Relief Foundation and Rodeo, Facility and/or any and all sponsors (including their officers, directors, employees, volunteers, agents or affiliates) concerning, arising out of, or in any way related to the actions, causes of actions, claims and demands hereby waived, released or discharged by the undersigned. If the participant is a minor, then the Signor covenants the same on behalf of the minor.

ASSURANCES: The Signor has full power, authority, capacity and right without limitation to execute, deliver and perform this Release, whether for himself/herself, or on behalf of his/her minor child or ward. The Signor further represents that the participant is in good health and has no medical, physical, or mental impairments or problems that would prevent him/her from safe participation in the event(s) or require special care, equipment or attention.

BINDING EFFECT: This Release shall be binding not only upon the Signor but also upon the Signor's spouse, legal representative, heirs, successors and assigns. This Release has been carefully and fully read by the Signor and the Signor fully understands its terms and conditions and has voluntarily executed and delivered this Release as of the date below.
